NOTES

1. For membership postal applications or enquiries please contact Mike Peters, 3 Meadowfields Drive, York YO31 HW (☎: 01904 626815) or via email to membership.nesc@gmail.com . Please enclose cheque for fees (payable to NESC) and a Stamped Addressed Envelope with postal applications for the return of your membership card.
2. A training form **MUST** be submitted with the application form for each child in Teaching or Coaching.
3. Children can be put on the waiting list from the age of 3 ½ and can start in the Teaching scheme from the age of 4 ½. Children on the waiting list do not need to be members of the club. If you don't want to take out membership for your child until they start lessons, complete the waiting list form and the training form.
4. During lessons, for all swimmers aged 11 or under a parent/guardian or nominated adult must be present in the spectator area and must remain for the duration of the lesson.
5. Junior members will be issued with a “non-swimmer” card unless they are capable of swimming unaccompanied at the deep end of the pool (6ft 6ins).
6. For each junior member, a responsible parent or guardian must be a member of the Club. This should be the adult who normally brings the swimmer to the pool. Non-swimming adult membership costs £8.00.
7. There will be a £2 administration fee to replace lost or damaged membership cards.
8. NESC is a non-profit making organisation. All of the Teachers/Coaches, Committee Members and other roles within the club are volunteers who give their time so you and/or your child can enjoy the fun and health benefits of swimming. Can you support the club by offering your time? We always need:
 - Life Guards
 - Teachers/Coaches
 - Door Supervisors (responsible for checking membership cards during recreational sessions and recording how many swimmers attend).
 - Administration help

Full training is given. We offer free family membership or free swimming lessons (for one child) to all of our Qualified Teachers, Coaches and Life Guards (max of one claim per family). Door Supervisors receive a £10 discount on their membership fee.

9. NESC membership provides free entry to the recreational sessions run by the Club. Children aged 7 or under must be accompanied by a person aged 16+ (either a member or guest). The recreational swimming times are:

Tuesday	7.00pm-9.00pm	Adults only 8.00-9.00pm
Friday	7.00pm-8.30pm	Junior swimmers with accompanying adults 7.45-8.30pm (adults must be in the pool)
Saturday	2.00-3.30pm	
Sunday (am)	9.00am-10.30am	
Sunday (pm)	2.00pm-3.30pm	

(Note all sessions are subject to the availability of volunteer door supervisors and life guards).

10. Data Protection Act (DPA) – New Earswick Swimming Club will process your data and hold it securely in accordance with the DPA. Data will be used to help to administer the club.
11. Email addresses. We use your email address to inform you about pool closures, session cancellations etc or, for children in the Teaching or Coaching Section, for club newsletters/announcements. Your email address will not be shared with external organisations but may be seen in the address line by other NESC Members.
