NOTES

2. Children can join our waiting list from the age of 3 ½ years old and can start in the Teaching scheme from the age of 4 ½. Children on the waiting list do not need to be members of the club.
3. During teaching lessons or training sessions, for all swimmers aged 11 or under, a parent/guardian or nominated adult must be present in the spectator area and must remain for the duration of the lesson.
4. Junior members will be issued with a “non-swimmer” card unless they are capable of swimming unaccompanied at the deep end of the pool (6ft 6ins).
5. For each junior member, a responsible parent or guardian must be a member of the Club. This should be the adult who normally brings the swimmer to the pool. If the parent/guardian does not wish to swim at the club then they must take Non-swimming Adult membership at a cost of £10.00 (no membership card is issued)
6. There will be a £2 administration fee to replace lost or damaged membership cards.
7. NESc is a non-profit making organisation. All of the Teachers/Coaches, Committee Members and other roles within the club are volunteers who give their time so you and/or your child can enjoy the fun and health benefits of swimming. Can you support the club by offering your time? We always need:
 - o Life Guards
 - o Teachers/Coaches
 - o Door Supervisors (responsible for checking membership cards during recreational sessions and recording how many swimmers attend).
 - o Administration
 - o Fundraising
8. NESc membership provides free entry to the open swim sessions run by the Club. During these sessions, children aged 8 or under must be accompanied in the water by an adult, at a ratio of 1 adult to 2 children. The open swim times are:

Tuesday	7.00pm-9.00pm	(8.00-9.00pm - Adult Lane swimming only)
Friday	7.00pm-8.30pm	(7.45-8.30pm – Lane Swimming Only. Junior swimmers must be accompanied in the water by an adult)
Saturday	2.00-3.30pm	
Sunday	9.00am-10.30am	
Sunday	2.00pm-3.30pm	

(Note all sessions are subject to the availability of volunteer door supervisors and life guards).

9. Junior swimmers who join SwimFit will not be issued with a membership card.
10. NESc will process your data and hold it securely in accordance with the DPA. Data will be used to help to administer the club. We do not share your data with any other organisations except, for Junior/Masters Swimmers, Teachers/Coaches and Volunteers whose name and address are recorded with the Amateurs Swimming Association. We use your email address to inform you about pool closures, session cancellations etc or, for children in the Teaching or Coaching Section, for club newsletters/announcements.
